**Interview with Complainant:** Bratt, Assistant Principal Hilton Head Island Elementary School  
 Bratt stated that one of her teachers (Amy Dungan) observed the Suspect holding what appeared to be a small razor blade. Bratt said that when asked about the object, the Suspect said that it was the metal insert of a child's pencil sharpener which he brought to school from home in order to sharpen his pencil. Bratt said that the Suspect was a very good student and has not been in any previous trouble. Bratt notified the Suspect's mother [redacted] who responded to the school and met with me and the Complainant.

**Interview of Suspect:** [redacted]  
 [redacted] said that while he was using his pencil sharpener at home the day before, it came apart. He said that he took the small piece of metal, which was inside the sharpener, to school in order to use on his pencil. [redacted] said that he did not bring the piece of metal to school for any other purpose.

**Officers Actions/Observations:**  
 Upon arriving at the school and meeting with Assistant Principal Bratt, [redacted] and the Suspect, I was shown the small piece of metal from the pencil sharpener which Assistant Principal Bratt had confiscated. The piece of metal was about 3/4" in length by about 1/4" in width. It was obvious that it was the metal insert commonly found in a child's small, plastic pencil sharpener. The Suspect also had a piece of pencil which was about 1" in length which appeared to have been recently sharpened. It was clear from the Suspects reaction, i.e., crying, that he understood it could be a problem bringing anything that might resemble a weapon onto school property.

**Additional Information:**  
 Assistant Principal Bratt stated that she needed to keep the piece of metal for a School District hearing which would be held to determine what if any further action would be taken in this incident. The Suspect's mother said that she did not want the piece of metal returned to her. Bratt said that the Suspect would at least be suspended for the remainder of today and all day tomorrow.

**Summary:**  
 Based on my discussions with the parties involved I do not believe there was any criminal intent in this incident.
